We hold that in a case where the offense is committed within 1,000 feet of certain enumerated public buildings or facilities, the word "unlawful" in the second degree of section 843.01(3), Florida Statutes (1987), is superfluous and unnecessary. Proper grammar requires that the word

"unlawful" be an adjective modifying the noun "entry." For example, if one were to write "entry unlawful," that would mean that the entry was unlawful, and the statute would require only that the entry be unlawful. Here the culpable act is the making of the unlawful entry, not the unlawful entry. In other words, if the first clause of the statute were amended to read "makes an entry... of any facility which he knows is not open to the public," then the second clause would apply to the making of the entry, and the statute would require only that the entry be unlawful.
