According to reports Epic Games is also going to be present at the next E3 as a sponsor. This may be good news for Fortnite fans, as Battle Royale is one of the most played games at the moment. The first version of Dapper Lab will be available for download from this summer. A part of the game creation software will be free, but parts of it will be available for a fee.
