2007 the dot-com bubble
burst leaving behind a
mass of tech companies
that could no longer make
money. Theoretically, the
rate of venture capital
provided to private equity-
like vehicles, which the dot-

coms used to stay alive,
ended, but those
companies that survived,
eventually exited, and new
companies were created.
The private equity industry
never fully recovered.
PARC took advantage of
the expansion in the
software market and

created a new business (PARC Informatics), which launched the first successful crowdfunding platform in Europe (We are currently at the beginning of a new cycle, from startups to late-stage venture capital, and the general pattern so far is

that the "late-stage" capital is not very late in the game. It represents an accumulation of capital that has been used to 'match' investments of the first stage of the cycle. In 2017 we started noticing that the capital raised by one-hit wonders such as

Canary, Outscale, Coo, Cruise and many others has exceeded the capital in the bank and that the likely 'exit' is acquisition at a premium to their market multiple. We expect this trend to continue in the first half of 2019. For example, in the last week

and a half it has become clear that the valuations of some of the companies offered on our platform have exceeded the market average multiple. As the technology companies on our platform reach the end of their life, we expect that the most promising

technology companies will also attempt to exit. On one hand, this is just the natural end of a business and we will see the same for others such as the ones acquired in 2016 or the five that had their IPO in Q3 2018. On the other hand, some of the cash is

likely to continue to
